## InvaPact Workshop Non-Disclosure Agreement (NDA)

### **1. Confidential Information**

The Disclosing Party agrees to provide certain confidential and proprietary information to the Receiving Party as part of their participation in any of the InvaPact workshops, which includes, but is not limited to:

- Database content, structure, and methodologies related to InvaPact or developed during any of the workshops.
- Research materials, strategies, and proprietary methods disclosed in the course of any of the workshops.

### **2. Non-Disclosure Obligations**

The Receiving Party agrees to the following:

- **Confidentiality:** Do not disclose, share, or distribute any part of the workshop content, database, methodology, or materials with any third parties without the prior written consent of the Disclosing Party.

- **Database Use:** The database and materials provided during the workshops are for use only in the projects in which the Receiving Party is directly involved. Use of the database for any other purposes, or in projects not directly assigned to the Receiving Party, is strictly prohibited unless written approval is obtained from the Disclosing Party.
- **Data Security:** Ensure that all materials received as part of the workshop are kept confidential, secure, and used solely for purposes approved by the Disclosing Party. The materials should not be copied, shared, or distributed in any form without explicit permission.

### **3. Duration of Confidentiality**

This Agreement will remain in effect for a period of one year following the completion of the InvaPact III workshop, during which the Receiving Party shall continue to maintain confidentiality. This period can be shortened in collective agreement if progress allows the database to be left in Open Access.

### **4. Return or Destruction of Materials**

Upon request by the Disclosing Party, the Receiving Party shall return or destroy any documents, materials, or data related to the workshop and the confidential information shared.

### **5. Remedies for Breach**

The Receiving Party acknowledges that any breach of this Agreement will result in irreparable harm to the Disclosing Party and other participants in the workshops. As such, the Disclosing Party is entitled to seek legal remedies, including injunctive relief, in the event of any breach or threatened breach.

### **6. Acknowledgment of Guidelines**

The Receiving Party acknowledges that they have read and understood the Authorship Guidelines (attached as a separate document) and agree to adhere to them throughout the course of their involvement with the InvaPact project.
